

# Topper's Pizza Deerhurst Getaway (the "Contest") COMPLETE CONTEST RULES (the "Rules")

## HOW TO ENTER

1. **NO PURCHASE NECESSARY.** To be eligible for a chance to win a Prize (as defined below) in this Contest, scan the QR code provided after purchasing any Participating Product (as defined below) from a Participating Retailer (as defined below) during the Contest Period, while supplies last. The Contest opens at 12:00 am Eastern Time ("ET") on November 4, 2024 and ends at 11:59 pm ET on January 5, 2025 (the "Contest Period"). Limit of one (1) entry, per person, per day. Any personal information submitted will be used for the purposes of contest administration and for no other reason unless specifically provided on the entry form.

**Alternate Methods of Entry:** To enter without making a purchase during the Promotion Period, entrants may do any of the following; sign up for the Topper's Pizza newsletter, create a post on social media (Instagram or Facebook) and tag Topper's (post must be valid on profile at the time of winner selection).

## PRIZE DESCRIPTION

## GENERAL

5. Draw winner will be notified by email (as provided on the entry form) or social media (account must allow for messaging) within 48 hours of the Draw Date. If the entrant does not respond within 3 business days another entrant's name will be drawn for a chance to win. If the alternate does not claim the Prize within 48 hours, the Prize will not be awarded.
